Introduction

On March 14, 2025, President Trump rescinded former President Biden's April 2021 executive order requiring federal contractors to pay a \$15 hourly minimum wage to workers for new federal contract solicitations starting Jan. 30, 2022 and increasing to \$17.75/hour in 2025. Federal appeals courts have taken different positions on the legality of the 2021 order, and the Department of Labor rules implementing the order remain in place. Executive Order 13658 — which was implemented by the Obama administration and requires federal contractors to pay \$13.30/hour — also remains. Numerous states have taken action to gradually increase the minimum wage to at least \$15/hour for most employees. To help employers prepare and address related issues, this roundup provides links to federal and state resources from organizations, government websites, third-party resources and news articles. The aggregated content in each section is organized in reverse chronological order and is by no means comprehensive. The content also does not necessarily reflect Mercer's or the authors' point of view on the subject.

Section 1

Federal

On March 14, 2025, President Trump rescinded former President Biden's April 2021 executive order requiring federal contractors to pay a \$15 hourly minimum wage to workers for new federal contract solicitations starting Jan. 30, 2022 and increasing to \$17.75/hour in 2025. Federal appeals courts have taken different positions on the legality of the 2021 order, and the Department of Labor rules implementing the order remain in place. Executive Order 13658 — which was implemented by the Obama administration and requires federal contractors to pay \$13.30/hour — also remains. In 2021, the House and Senate introduced legislation to progressively increase the minimum wage to \$15/hour by 2025, but it did not pass.

The federal minimum wage is \$7.25/hour effective July 24, 2009.

Thirty states, along with Washington, DC, Guam, Puerto Rico and the US Virgin Islands, have set their minimum wage higher than the federal level of \$7.25/hour, and the trend is to move toward at least a \$15/hour minimum wage rate for most employees.

Section 3

States and cities committed to at least a \$15/hour minimum wage rate

Alaska, Arizona, California, Connecticut, Delaware, Florida, Hawaii, Illinois, Maryland, Massachusetts, Missouri, Nebraska, New Jersey, New York, Oregon, Rhode Island, Washington and Washington, DC, have committed to increase the general minimum wage rate to at least \$15/hour. Some cities in other states have also committed to at least a \$15/hour minimum wage. Michigan's minimum wage will increase to \$14.97 by 2028.

Alaska

On Nov. 5, 2024, voters in Alaska [approved](#) a ballot measure that will increase the minimum wage from \$11.91/hour to \$15/hour by July 1, 2027.

Arizona (Flagstaff and Tucson)

On Jan. 1, 2025, Arizona's minimum wage increased to \$14.70/hour, up from \$14.35/hour. It is expected to increase to \$15.15/hour for 2026.

On Jan. 1, 2025, Flagstaff's minimum wage increased to \$17.85/hour, up from \$17.40/hour in 2024. On Jan. 1, 2026, it will increase to \$18.35/hour for all covered employees.

On Jan. 1, 2025, Tucson's minimum wage rate increased to \$15/hour, up from \$14.25/hour in 2024.

California

On Jan. 1, 2025, the minimum wage increased 3.5% to \$16.50/hour, up from \$16/hour for all employees. It will increase to \$16.90/hour on Jan. 1, 2026. Numerous counties and cities in California have higher minimum wage rates. For example, Los Angeles' minimum wage rate increased to \$17.87/hour on July 1, 2025, up from 17.28/hour. On July 1, 2025, San Francisco's minimum wage rate increased to \$19.18/hour, up from \$18.67/hour.

On March 26, 2024, the governor signed legislation (AB 610) that exempts restaurants in airports, hotels, large event centers, theme parks, museums, gambling establishments and certain other locations from the minimum wage law that took effect on April 1, 2024. Bakeries and restaurants in grocery stores were already exempt under the law.

On April 1, 2024, certain fast food workers began earning \$20/hour, under legislation ([AB 1228](#)) [signed](#) by the governor on Sept. 28, 2023. The Fast Food Council can increase the wage annually, but the increase will be capped at the lesser of 3.5% or the annual increase in the US-CPI for Urban Wage Earners and Clerical Workers.

On Oct. 13, 2023, the governor [signed](#) legislation ([SB 525](#)) to progressively increase the minimum wage for many health care workers to \$25/hour by 2026. Workers at large health care facilities now earn \$24/hour as of July 1, 2025, and they will earn \$25/hour as of July 1, 2026.

Beginning Jan. 1, 2028, the minimum wage will be adjusted for inflation each year. For the remaining health care workers, the minimum wage will more gradually increase to \$25/hour. The Department of Industrial Relations [issued](#) FAQs that provide the different rates. Certain cities — for example, Los Angeles, Monterey Park and Long Beach — already have a \$25/hour minimum wage for health care workers.

Colorado — Denver, Boulder and Edgewater

Colorado's minimum wage rate is \$14.81/hour, but it is expected to increase to \$15.16/hour on Jan. 1, 2026. On Jan. 1, 2025, the city and county of Denver minimum wage rate increased to \$18.81/hour, up from \$18.29/hour in 2024. It will increase to \$19.29/hour on Jan. 1, 2026.

On Jan. 1, 2025, the City of Boulder approved a minimum wage increase of \$15.57/hour. The rate will increase to \$16.82/hour and to \$18.17/hour for 2027.

On Jan. 1, 2025, the local minimum wage in unincorporated Boulder County increased to \$16.57/hour, up from \$15.69/hour in 2024.

The City of Edgewater's minimum wage is \$16.52. It will increase to \$18.17/hour for 2026, \$19.99/hour for 2027, \$21.99/hour for 2028 and \$23.26/hour for 2029.

Washington

On Jan. 1, 2025, Washington's minimum wage increased to \$16.66/hour for employees aged 16 or older, up from \$16.28/hour. It is expected to increase to \$17.13/hour for 2026.

Employees aged 14 to 15 years must be paid at least \$14.16/hour in 2025, up from \$13.84/hour. Large employers with 51 or more employees must pay exempt employees at least twice the minimum wage to be exempt from overtime requirements. Small employers with up to 50 employees must pay exempt employees 1.75 times the minimum wage to be exempt from overtime requirements. Exempt computer professionals paid hourly must be paid at least 3.5 times the minimum wage.

In Seattle, the minimum wage for 2025 is \$20.76/hour for all employers. Small businesses can no longer make up any part of the minimum wage with tips or medical benefits that are paid to their employees.

In SeaTac, the 2025 minimum wage is \$20.17/hour for hospitality and transportation workers — up from \$19.71/hour in 2024.

In Tukwila, the minimum wage [increased](#) to \$21.10/hour on Jan. 1, 2025 (up from \$20.29/hour for employers with more than 500 employees), and to \$20.10/hour (up from \$18.29/hour for employers with 15–500 employees). On July 1, 2025, mid-size employers are required to increase their minimum wage rate to the same \$21.10 rate as large employers. Smaller employers are not covered by Tukwila's minimum wage law. On Jan. 1, 2026, the minimum wage will increase to \$21.65/hour for all employers.

In May 2024, the King County Council approved a proposal that set the minimum wage to \$20.29/hour (plus inflation increase) across unincorporated King County beginning Jan. 1, 2025. Employers with 15 or fewer employees and an annual gross revenue of less than \$2 million will have an hourly minimum wage rate of \$3 less (\$17.29/hour). The reduction would decrease annually by \$0.50/hour until no reduction remains in 2030. Meanwhile, employers with 15 or fewer employees and an annual gross revenue of \$2 million or greater and

employers with more than 15 employees but fewer than 500 employees will have an hourly minimum wage rate of \$2 less (\$18.29/hour). The reduction will decrease annually by \$1/hour until no reduction remains in 2026.

On Feb. 13, 2024, Renton voters passed an initiative for Renton employers to pay the same minimum wage as the City of Tukwila — beginning July 1, 2024. In 2025, the minimum wage in Renton increased to \$20.90/hour for large employers that have more than 500 employees. The rate for mid-sized employers (with five to 500 employees, or that have over \$2 million in annual gross revenue) is \$18.90/hour from Jan. 1, 2025, through June 30, 2025, and it will increase to \$19.90/hour from July 1, 2025, through Dec. 31, 2025.
